

# NCCC Student Guide Info, Agreement & Release



Welcome to Coastal Music Studios and the North County Children's Choir. As a community of artists, it is our hope to see you realize your dreams as we embrace the art of musical performance together.

Following are guidelines, waivers and liability releases for all participating Coastal Music Studios and North County Children's Choir students and families.

Submitting your online registration confirms that you have read, understand and agree to these terms, and that your child has permission to participate in the North County Children's Choir.

## STUDENT CODE OF CONDUCT

All students are expected to act respectfully to their teachers and classmates while participating in the NCCC. Behavior and language that is disrespectful or disruptive to a positive learning environment will not be tolerated.

## REHEARSAL & PRACTICE TIME

Please make every effort to be on time and attend all rehearsals so that the choir can learn the material and how to best perform together. Also, we encourage your student to practice daily. Improvement comes when you spend time honing your craft. With this choir only rehearsing once per week, there will need to be some rehearsal at home to learn the songs.

## DROP-OFF & PICK-UP

Students should **ONLY** be dropped off at the front door of our studio. Please **DO NOT** enter through the rear alley so that we can be respectful to our neighboring businesses. There is parking on the street and the North side of our building. We will have an adult out front welcoming students at the start of choir. At dismissal, we will not release any student from inside the studio until we see their parent/guardian at the front door. **NO EXCEPTIONS!**

## PHOTO RELEASE

North County Children's Choir has permission to use images, photography and/or video and audio recordings of my child for the purposes of advertising, publicizing and promoting the choir and Coastal Music Studios. These images, video and audio may appear in either or both print and digital media.

## LIABILITY & MEDICAL RELEASE

Participation is voluntary and I agree to assume all risks for involvement in choir functions. I authorize the student named in the online registration form to participate in the Coastal Music Studios North County Children's Choir. I further hold Coastal Music Studios, any of its staff, teachers, volunteers, spouses and their heirs, harmless from any accidental injury that may occur while participating in the NCCC. I give consent for my child (student) to be examined and receive emergency treatment as needed by a physician as a result of injuries and/or sickness while participating in the NCCC. I have carefully read the above release and indemnity agreement and fully understand its contents. I am aware that this is a release of liability and agreement to indemnify Coastal Music Studios and the North County Children's Choir and I authorize this release of my own free will.
